Gov – Governor

F&P T&L – Teaching SEND – Special Educational Needs and Disabilities

B&S Per – Personnel Committee

LAC – Looked After Children

PPG – Pupil Premium Grant (an additional budgetary allowance linked to Free School entitlement.)

SCR – Single Central Record – A record of school staff and pupils – a legal requirement used to calculate school funding.

Headteacher Performance Management (with an External Assessor).

Pupil Exclusions – Usually Co-Chairs and one other. Governors who are employed by the school should not take part.

Pupil Disciplinary Governor Hearing – any Governor.

Staff Disciplinary Panel - Any Governor not employed by the school.

Staff Disciplinary Appeals Panel – Any Governor not employed by the school who was not on original Disciplinary Panel.
