LAC - Looked After Children

PPG – Pupil Premium Grant (an additional budgetary allowance linked to Free School entitlement.)

SCR - Single Central Record - A record of school staff and pupils - a legal requirement used to calculate school funding.

Headteacher Performance Management (with an External Assessor).

Pupil Exclusions - Usually Co-Chairs and one other. Governors who are employed by the school should not take part. Pupil Disciplinary Governor Hearing - any Governor.

Staff Disciplinary Panel - Any Governor not employed by the school.

Staff Disciplinary Appeals Panel - Any Governor not employed by the school who was not on original Disciplinary Panel.
